General Terms and Conditions:

1. Ad-hoc/contract appointment shall be made for a period of a maximum of Eleven months (11) from date of joining or till the regular faculty joins, whichever is earlier, purely on contract basis on a consolidated salary of *Rs.50,000/- per month (which includes all allowances) for possessing U.G. Degree; *Rs.60,000/- per month (which includes all allowances) for possessing P.G. Degree and *Rs.70,000/- per month (which includes all allowances) for possessing Ph.D. Degree.
2. Candidates fulfilling above eligibility criteria may visit the School as per INTERVIEW SCHEDULE to be displayed on our website www.spa.ac.in .
3. Interested candidates may apply in the prescribed Application Form alongwith Application Fee.

Fee for SC/ST/PWD/EWS/Women Candidates are fully exempted.

4. Adequate computer proficiency is essential for all the faculty positions.
5. The School reserves the right to decide the number of posts in respective position.
6. An applicant has to ensure authenticity of information, documents and photograph.
7. No TA/DA shall be paid to the candidates for attending the interview.
8. Candidates having Foreign Universities' Degrees should produce 'Equivalence Certificate' from Association of Indian Universities (AIU), New Delhi.
9. Keeping in view of the regular faculty notification issued in the recent past, the present ad-hoc selection is purely temporary and on 'contract basis' and does not provide for any regularization in service in the School.
10. Candidates have to report at SPA, New Delhi campus as per Interview Schedule.
11. Candidate may be asked to make a short Power Point Presentation (10 minutes maximum) on a topic of their interest during the interview.
12. The Reservation to SC/ST/OBC/PwD candidates shall be applicable as per directives of the Government of India amended from time to time. Candidates should produce certificate issued from a Competent Authority.
